Model Release

- The Client grants the Photographer permission to use the images for promotional purposes unless otherwise specified in writing.

Liability

- The Photographer is not liable for any loss, damage, or failure to deliver images due to circumstances beyond their control.

Indemnification

- Both parties agree to indemnify and hold harmless against any liabilities, claims, or expenses resulting from the performance of this agreement.
