- The Photographer will deliver the final edited images to the Client within afte the event/session. - Delivery method will be agreed upon by both parties.				
Model Release				

- The Client grants the Photographer permission to use the images for promotional purposes unless otherwise specified in writing.

Liability

- The Photographer is not liable for any loss, damage, or failure to deliver images due to circumstances beyond their control.
