## 1. Booking and Payment:

1.1 To secure a booking, a non-refundable deposit of 50% of the total package price is required. The remaining balance is due on the day or before the scheduled session/event.

1.2 Payments can be made via EFT/Card Payments/Online Card Payments/Cash

## 2. Cancellation and Rescheduling:

2.1 In the event of cancellation, the deposit is non-refundable. However, clients may reschedule the session/event, subject to availability.

2.2 KJD Photography reserves the right to cancel or reschedule due to unforeseen circumstances. Every effort will be made to provide an alternative date or a full refund.

## 3. Photography Services:

3.1 The photographer will provide [details of services offered - e.g., number of hours, edited images, etc.] as outlined in the agreed-upon package.

3.2 Any additional services requested on the day of the session/event may incur extra charges.

## 4. Image Rights and Usage:

4.1 KJD Photography retains the copyright and ownership of all images taken during the session/event.

4.2 Clients are granted personal usage rights to the images for non-commercial purposes only, including printing, sharing on social media, etc.

4.3 Clients must not edit, filter, or alter the images provided by KJD Photography without explicit permission.

## 5. Model Release:

5.1 Clients agree to allow KJD Photography to use images for promotional purposes unless otherwise specified in writing before the session/event.

## 6. Client Cooperation:

6.1 Clients will cooperate with the photographer to achieve the desired results, including but not limited to timely arrival, following guidelines, and providing necessary information.

## 7. Liability:

7.1 KJD Photography is not liable for any unforeseen events that may disrupt or prevent the photography session/event, but will make every effort to provide a suitable alternative or refund. We have also invested in professional studio battery powered lighting in cases of loadshedding we can continue the shoot.

7.2 In the unlikely event of any other equipment failure or other circumstances beyond control, liability is limited to a full refund of any payments received.

## 8. Client's Personal Property:

8.1 KJD Photography is not responsible for any loss or damage to the client's personal property during the session/event.

## 9. Privacy Policy:

9.1 KJD Photography respects client privacy and will not share personal information with third parties without consent unless required by law.

## 10. Governing Law:

10.1 This agreement shall be governed by and construed in accordance with the laws of South Africa.
